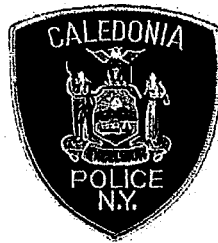
- 1) Super Bowl DWI Grant Crackdown, Caledonia PD issued 5 traffic tickets
