# Village Board Meeting Minutes February 2, 2021

The Village of Caledonia Board of Trustees held a meeting on Tuesday, February 2, 2021 at 6:30 p.m. at the Village Office.

Christmas trees were picked up, cold patching complete, snow/ice control continues and 43 tons of salt used to date. The equipment trailer was repaired and painted. The bucket truck will be painted soon too. The new 6-wheel dump truck should be ready for use February or early March. New outdoor lights were installed at the Village Office.

## Resolution #2:

WHEREAS, the Village of Caledonia applied for the funding through the Green Innovation Grant Program for the replacement of aged water meters with radio read meters and related hardware and software, and

WHEREAS, the total project budget is \$162,000; and

WHEREAS, the GIGP requires the Village of Caledonia to enter into an agreement with the New York State Environmental Facilities Corporation (NYSEFC) and the Village Board does hereby accept that they shall provide at least 25% match of the total of any grant funding awarded as a local match in the form of in-kind services or cash contributions hereby appropriated and obligated from the Water Fund; and

**NOW, THEREFORE, BE IT RESOLVED,** that the Village of Caledonia Village Board agrees to enter into an agreement with NYSEFC for the completion of this GIGP project and authorizes Mayor Scott DiLiberto to sign paperwork related to this project on behalf of the Village.

**NOW, THEREFORE, BE IT RESOLVED,** that the Village of Caledonia Village Board authorizes up to \$40,500 to be expended from the Water operating budget as a 25% match.
