## **I. RATES, FEES, AND OTHER CHARGES FOR WATER SERVICE**

Rates for sale of water to all customers of the Village of Caledonia Water Department.

### **1.1 BILLING**

All billing of charges for water and water services is in arrears. Water usage is billed quarterly. All charges for service connections are payable in advance.

### **1.2 RETAIL SERVICE METERED RATES**

#### **A. Base Charge**

\$35.00 per unit/per quarter

#### **B. Commodity Charge (per 1,000 gallons)**

The charge for all water consumption.

- (1) **Residential Class:** includes all residential, small Commercial and community service establishments in the Village of Caledonia. \$7.25
- (2) **Non-Residential Class:** includes large commercial and industrial customers in the Village of Caledonia. \$7.25

### **1.3 WHOLESALE SERVICE METERED RATES**

#### **A. Base Charge**

\$35.00 per unit/per quarter

\*Excluding Livingston County Water & Sewer Authority  
Caledonia District #1 & #2.

#### **B. Commodity Charge (per 1,000 gallons)**

The charge for all water consumption.

- (1) **Wholesale class** including Caledonia Districts #1 & #2  
\$2.96
- (2) **Wholesale class** including Iroquois Road LLC  
Manufactured Home Park. \$10.50

**1.4 FIRE PROTECTION RATES**

A. Private Fire Protection

- (1) There is no charge for private hydrants, fire sprinklers systems, and service lines sized for fire protection.
- (2) There is no charge for metered sprinkler systems in Residential homes.
- (3) There is no charge to fire districts for privately owned hydrants used expressly for training or in the conduct of fire-fighting operations.

B. Public Fire Protection

There is no charge for fire districts for fire protection furnished through hydrants located on a street in the public right-of-way, or on an easement granted to the Village of Caledonia.

**1.5 ACCOUNT CHARGE**

There is no charge for acquiring or transferring an account.

**1.6 SERVICE CONNECTION CHARGE**

A. A service connection charge shall be paid by each new applicant for each new service and meter installation on an existing water main prior to approval of the application. The service connection charge includes the installation of a one (1") inch water service within the public right-of-way or easement, a 5/8-inch by 3/4-inch meter, and the creation of a new account.

Service Connection Charge \$1,500.00

- (1) The Village of Caledonia reserves the right to

charge any applicant for service any additional direct costs as determined by the Village necessary to the installation of the new service.

- (2) New water services greater than 1-inch in diameter or new water meters larger than 5/8-inch by 3/4-inch will be charged at cost.

A. Meter Test - Customer's Request

Up to 1"	\$50.00
1 1/2" & 2"	\$75.00
Over 2"	At Cost

B. Frozen Meter

(1) 5/8" by 3/4"	
Each incident	\$255.00
(2) 1" & Over	At Cost

C. Special Service - by application only

- (1) Temporary Service - a complete 1-inch water service to supply water for a short period.

Temporary Service Installation -	\$500.00
Temporary Service Abandonment -	At Cost
Deposit -	\$100.00

Water Service Meter Rates - Per Section 1.2B

- (2) Hydrant Supply - Irrigation or Construction - Water supply from an authorized hydrant with meter and backflow prevention installed and removed by Village of Caledonia Water Department only.

Deposit - \$100.00

Equipment Use Fee - \$35.00

Water Service Meter Rates - Per Section 1.2B

Hydrant Supply - Community car washes and not-for-profit uses - Water supply from an authorized hydrant with meter and backflow prevention installed and removed by Village of Caledonia Water Department only.

Equipment Use Fee - \$10.00

D. Unauthorized Use or Operation Fee

Any unauthorized use or operation of the Village of Caledonia water supply \$500.00 + Costs Incurred

E. Service Discontinuance Fee

Water service discontinued due to noncompliance of the Village of Caledonia's Rules & Regulations \$75.00

F. Service Status Change - Customer's Request

(1) Shut Off and/or Meter Removal \$25.00

(2) Turn ON and/or Meter Set \$25.00

G. New Meter Replacement

Residents contacted to replace their existing meter with a new Badger Orion meter have 30 days to do so. The Village Clerk's Office will mail letters. Failure to Schedule an appointment within 30 days of the letter date will result in a \$25.00 penalty added onto each quarter billing until the meter is replaced.

## 1.8 DELINQUENCY CHARGES

### A. Late Payment

Accounts become delinquent thirty (30) calendar days  
after a billing date. 10% of current bill

### B. Returned Payment

Returned check or electronic payment fee. \$35.00

### C. Service Discontinuance

Any water service account which carries an unpaid  
balance of three quarters past the due date is subject  
to discontinuance of service and the following  
additional charge at the time of restoration. \$50.00

## 1.9 LABORATORY SERVICES

The Village of Caledonia can have water sampled for bacteri-  
ological quality.

A. Water sample testing fee \$50.00

B. Other tests as requested or required At Cost

The Village will provide sample containers and supplies.
